The Coalition for the International Criminal Court (CICC) includes 2,500 civil society organizations in 150 different countries working in partnership to strengthen international cooperation with the International Criminal Court (ICC); ensure that the Court is fair, effective and independent; make justice both visible and universal; and advance stronger national laws that deliver justice to victims of war crimes, crimes against humanity and genocide. The ICC is the first permanent Court with the mandate to bring to justice individuals who commit the most serious violations of international humanitarian law, namely genocide, crimes against humanity and war crimes.

The Coalition is looking for a Communications/Translation Intern for its international secretariat in The Hague, Netherlands to assist with a range of media and public-information projects as well as with necessary translations and interpretation from English to French.

### **QUALIFICATIONS**

We are interested in applicants whose studies were/are related to Languages or Translation, Communications, Journalism, International Relations, Political Science, Law and/or other relevant fields. Applicants with a legal background are also encouraged to apply. Native or Near-native level of French, a good command of English, and strong written skills in both languages are required.

### **DURATION OF THE INTERNSHIP**

The Internship would be for a minimum of three months, starting as soon as possible. The intern will report to the Head of Communications, among other Section staff. The internship can be full or part-time, with a minimum of 20 hours per week.

### **WHAT TO EXPECT**

The Intern will assist the Communications team in its daily work.

The intern will in particular help the team in monitoring and compiling news developments related to the Court's current investigations and cases.

The intern will help monitor, attend and report on these events.

The intern will also help in the production of Coalition's communications tools when needed, including its publications and website in French and English.

The intern will provide necessary translations from English to French.

The intern will provide interpretation from English-French, and vice-versa, in meetings and other events when required.

This internship provides the opportunity to work in an enthusiastic, small and young international team, part of a large international secretariat and a global network and learn more on the Coalition's communications activities.

### **REMUNERATION**

Unfortunately, internships at the Coalition are unpaid. We recommend all prospective candidates to seek financial assistance from their academic institutions or seek outside fellowships, grants and personal resources. The Coalition cannot sponsor individuals applying for internships to help them obtain visas.
