#### **ICC Prosecutor holds roundtable briefing with the media**

On 25 April 2006, ICC Prosecutor Luis Moreno Ocampo held a roundtable briefing with the media at the ICC headquarters in The Hague. In the future, such a briefing will be held every month. Luis Moreno Ocampo informed the press about the first three years of the OTP, of the situations currently under investigations and of future plans.

#### **PTC 1 holds hearing on System of Disclosure**

On 24 April 2006, Pre Trial Chamber 1 held a Public Hearing on the System of Disclosure for the Purpose of the Confirmation Hearing. The aim of the Chamber was to hear the parties' interpretation of the articles related to disclosure. The hearing was followed by a closed session. The parties will follow up in writing by the 2nd of May.

The Regulations of the Registry were made public on 19 April 2006, after being approved on 6 March by the Presidency of the Court in accordance with Rule 14 of the Rules of Procedure and Evidence. #### **Special Court for Sierra Leone issues regarding the location of the trial of Charles Taylor including the ICC premises**

Beginning on 29 March 2006, there have been speculations about where the Special Court for Sierra Leone will hold the trial of former Liberian President Charles Taylor if it is not held in the Sierra Leonean capital of Freetown, including the possible use of the International Criminal Court's premises in The Hague.

### March 2006

#### **First Appearance of Mr Thomas Lubanga Dyilo before the ICC**

On 20 March 2006, ICC Pre-Trial Chamber I held a Public hearing during which Thomas Lubanga Dyilo appeared before the Chamber. The Pre-Trial Chamber I satisfied itself that Mr. Lubanga had been informed of the crimes which he is alleged to have committed, and of his rights under the Rome Statute. The confirmation of charges hearing was set for the 27 of June 2006.

### **First Arrest for International Criminal Court**

On 17 March 2006, the International Criminal Court announced that its Pre-Trial Chamber I had unsealed an arrest warrant concerning the situation in the Democratic Republic of Congo (DRC) for the leader of a political and military movement, the Union of Congolese Patriots (UPC), Thomas Lubanga Dyilo. The ICC also announced that Mr. Lubanga was arrested and transferred to The Hague. This is the first arrest for the new permanent Court. This is the first unsealed arrest warrant issued for the DRC situation, but it is expected to lead to subsequent requests for arrest warrants as the Prosecutor continues his investigation.

### **Presidency organizes Pre-Trial Chambers**

On 14 March 2006, the Presidency issued a Decision regarding the constitution of the Pre-Trial Chambers noting the election of six judges on 26 January 2006 and deciding that Pre-Trial Chamber I consists of Judge Claude Jorda, Judge Akua Kuenyehia and Judge Sylvia Steiner; Pre-Trial Chamber II of Judge Mauro Politi, Judge Fatoumata Dembele Diarra and Judge Ekatarina Trendafilova; and Pre-Trial Chamber III of Judge Hans Peter Kaul, Judge Sylvia Steiner and Judge Ekatarina Trendafilova.

### **ICC Prosecutor delivers OTP Update**

On 10 February 2006, the Prosecutor of the International Criminal Court (ICC) made public an update on communications received by the Office of the Prosecutor (OTP) of the ICC. The update provided that the office has received 1732 communications from 103 countries including reports on alleged crimes in 139 countries in all regions of the world. The update annexed two letters to senders of communications regarding the situations in

Iraq and Venezuela respectively, informing them that the Prosecutor has concluded not to initiate an investigation with respect to these situations (but that this can be reconsidered in light of new facts or evidence) and that he has not received any referrals from states in this regard.

## **January 2006**

### **6 ICC Judges elected**

On 26 January 2006, the Assembly of States Parties to the Rome Statute of the ICC (ASP) elected six of the 18 judges of the ICC. They will serve full terms of nine years. Five judges have been re-elected: Hans-Peter Kaul (Germany), Erkki Kourula (Finland), Akua Kuenyehia (Ghana), Sang-Hyun Song (Republic of Korea) and Anita Ušacka (Latvia). New to the bench is Ekaterina Trendafilova from Bulgaria, who will replace Tuiloma Neroni Slade from Samoa.
